Fees, Payments and Sums fixed and settled under Section 15 of the Local Authorities Cemeteries Order 1977

The residential fees, payments and sums set out in Parts 1 to 3 apply where the deceased person is an inhabitant of the <u>Civil Parish</u> of Cawston, or in the case of still-born children where the parents (or one of them) are such inhabitants.

For the purpose of determining fees, an inhabitant of Cawston is a person who is listed on the current Register of Electors. Former inhabitants who, at time of death, were resident in a retirement home located outside Cawston will be treated as inhabitants if they are listed on the current or previous four years Registers of Electors.
